- Membership across the division stands at 290. This is down from our base of 312, but we have added 65 new members this Toastmasters year.

- All Areas within Division A will hold a combined contest on Monday, February 17th, at St. Joseph's Church in Manchester. Area 5 is not sending any contestants, but Areas 2, 4, and 9 have contestants

for Evaluation and/or International Speech. Bret Nicolas has been instrumental is filling the functionary roles for these contests (thank you, Bret!)

- Centene Speaks intends to hold an Open House in March. More information to come (e.g. specific date).

1. Membership Growth and Retention:

- Current membership 67 clubs to date-base 76 numbers vs. goals.
- Membership growth Currently at 1048 members, which is a 68 member-increase from our last meeting.
- Retention -Club Retention Chair, Cynthia Scroggins will be holding club coach training sessions. Be on the lookout for upcoming dates

2. Club Development:

- On January 15th the CG team held a demo meeting with Coldwell Banker, and it went very well. Waiting on initial charter fee.
- On January 24th we held a demo meeting at SLU with at least 35 students and staff in attendance and it went extremely well. Elaine Curry and I are working with SLU to get this charter done.
- We are still in the process of scheduling a demo meeting with St Charles Community College

3. Marketing and Outreach Initiatives:

- Club New Source Chair, Annetta Works Salley will be holding speech craft sessions starting in February. Dates and times will be posted soon.
- Bring a lead-asking AD's, DD's and anyone else who has a lead to please bring them to the CG team.

Officer Training

Only 29 of 73 active clubs have gotten four officers trained during the winter session. We offered COT at the TLI and Dec/Jan team-teaching sessions

We have through Feb 28th for them to receive DCP credit for attending training.

Several have attended other district training courses.

We will offer another round of training in February, and we need you to help teach.

When you don't see those education goals being submitted, ask. Is it a lack of Pathways usage or is it officers not understanding their roles. Let's help our clubs be successful by working with them and providing them with the tools and information they need.

Speech Contest Review

- Roles
 - o Contest Chair
 - Organizer
 - Contest Master
 - Emcee (Toastmasters of the Day)
- Check on these things:
 - o Do you have them? Trophies Got them
 - o Date, location, time
 - Where is your copy? Rulebook
 - Recommend printing out the rulebook and forms and taking to the contest.
- Contestant Qualifications
 - o International Speech Contestants
 - Who is eligible?
 - Paid member of any club in the Area, Division & District
 - Completed 2 Levels
 - DTM
 - Who isn't eligible?
 - None of us (District Level)
 - Immediate Past District Director
 - Candidates for next year elected District positions (Trio, Div Directors)
 - Functionary in the contest they are competing in
- Evaluation Speech Contestants
 - Any paid member of a club in their Area, Division,
 - District that they are competing in may compete
- Contestant Eligibility
 - Where to look? Look them up = Use Membership Report
 - Eligibility of judges
 - Club Level be a paid member
 - Area. Division or District
 - Paid member for 6 months
 - Completed 2 Pathway levels or 6 speeches in Competent Communicator
 - Be physically present SAA
 - With the evaluation contest, you could use 3 SAA
 - Contest Room you move the evaluation contestants
 - To move contestants from their room back to the contest room
- Evaluation Contest
 - o Pattern Speaker paid Toastmaster
 - o Use of official Evaluation Contestant Notes sheet
 - Move to another room where for 5 minutes, they can formulate their speech based on their memory and notes they used.

After 5 minutes, collect Evaluation Contestant Notes sheet

International Speech Contestants

- Type of speech inspirational, humorous, tall tale
- May stay in the room hearing the other contestants or may opt to stay and not listen to the other contestants.
- If a contestant opts to be out of the room and not listen to the other contestants, the SAA must call the contestant during the period of silence after the previous contestant has concluded their speech.

Speeches are given

Protests - Only contestants & judges can lodge protests

Based on eligibility, originality, reference to another contestant or another contestant's speech 25% or less may be devoted to quoting, paraphrasing. Must reference any quoted or paraphrased material

Contest winners

- Notification of Contest Winner forms to next level Take a picture and post FB, D8 Members Only,
- LinkedIn, other social media that you use.
- Send it to the local newspaper with a little write-up noting your local club.
- Invite family, friends, colleagues and those you want to introduce to Toastmasters
- Questions?
- If there is a major weather event the date of the contest, it can be
- rescheduled.
- Areas with 4 or less clubs may send 2 contestants to each Area Contest
- I can't get enough judges the rules are there to protect against partiality. Do the best you can and move forward.
- Eligibility of judges and contestants can be checked using the Membership Report.
- Combining Area and or Division contests together is permissible and allows the task of getting functionaries
- Any other questions, please refer to the Speech Contest Rulebook.
