• Division C has a need to add 4 new clubs at a minimum. I note this for the record considering discussions with the Realignment committee and discussion this year with the Trio. We should especially consider filling the space that exists between Springfield and Effingham, Springfield, and Collinsville. This is a long-term project; an effort to build more corporate clubs may be a solid saving for the Illinois side of District 8. Again...this takes time, and we will need to dedicate more resources to this.

Mt Vernon Toastmasters, Area 11 Top Talk Toastmasters and Talk of Belleville. To my knowledge, as of March 1 no new club visits have been reported yet. Area directors have been reminded of a good methodology to complete these reports and complete the requirement.
- All clubs are pursuing renewals of membership, and we hope that more new members will be added by the end of the month. I need to know about the best methods to capture renewals to meet a weekly request by the Trio to report renewals outside of the distinguished performance dashboard.

Club Growth Director: Karen Dew Membership Growth and Retention:

• Currently we have 68 clubs. April Renewals currently at 155

• Retention rates-8 clubs under 8 members and strategies-train and assign club coaches and extend help to clubs with low numbers by filling in for roles until memberships improve.

•Second round of Area Club visits has started. Currently we have 22% completed, 12% report incomplete and 66% have not started yet. Leadership Wentzville needs support.

If you need help with visits, please let me know.

2. Club Development:

• Number of new clubs chartered and their progress. -We have 2 clubs that are currently working on Charter paperwork, Coldwell Banker, and SLU. Demo meeting is being worked on for St Charles Community College. We also have one additional prospect clubs that the CG team is in contact with (Booneville Correction Center)

3. Marketing and Outreach Initiatives:

- c. 7 clubs have reached distinguished if they keep their membership at 20 or more: South County, Noontime (MO), Capital City, Horace Mann, Collinsville, Toast of Belleville, Master Toasters & amp; Cave Springs
- d. 33 clubs have the potential let us help them. 12 clubs just need to work on their educational goals, 2 clubs just need more members and the 19 remaining need a combination of members & amp; education. e. Next emphasis will be on Pathways during my time training officers, most did not understand how to complete their project in Pathways; then. the VPE (or other officer) will check Base Camp Manager, check approvals, and then verify.
- f. 25 clubs without 1 educational level completed; 12 clubs with just 1 level completed.
